# REPORTS OF OFFICERS

<u>Treasurer's Report.</u> Mr. Cheney provided a financial report based on the year-end unaudited financial dated December 31, 2017.

- Maintenance Fees were lowered last year due to sub-metering revenue.
- Security was added in 2017 at a cost of approximately \$2500 per month. Security is staffed three days per week.

Mr. Smith commended Mr. Cheney for his work as Treasurer.

## **AUDITOR'S REPORT**

Terry Wong, CPA, is auditing the books for the accounting year ending December 31, 2017, and copies will be made available to the owner membership when it becomes available in mid to end of April 2018.

#### **ELECTION OF DIRECTORS**

President Smith stated that Section I of Article II of the project Bylaws specifies that the affairs of the Association shall be governed by a Board of Directors composed of not less than nine persons, all of whom shall be an owner, co-owner, vendee under an agreement of sale, or an officer of any corporate owner of an apartment. There were three vacancies on the Board, which had to be filled. Three directors were to be elected for a three year term.

Remaining on the Board were, Chris Cheney, Dawn Barrowcliff, George Burkley, Jerrold Williams, Gladys Kerr and Pam Cheney.
